ACCREDITATION

Friend Public School is accredited by the State of Nebraska and the North Central Association. As part of the accreditation process, Friend Public School utilizes the Advanc-Ed process which is a rigorous, on-site external review to ensure all learners realize their full potential.

OUR DISTRICT

Friend Public Schools is a state accredited Class 3 district located in the community of Friend on Highway 6 in the northwest corner of Saline County. The majority of the economic base for the 99 square mile school district is agricultural or ag - related. Adding to the \$444 million district valuation are locally owned industries and businesses.

The five year average (2010 - 2015) PreK - 12 enrollment is 288 students. Currently there are twenty eight certificated teachers (26.93 FTE) on staff, and two and one half administrators. Certificated staff to student ratio, based on the five-year average, is one certificated staff for every 10 students.

No Child Left Behind

Under the No Child Left Behind Act of 2001 (NCLB), all students are required to make “Adequate Yearly Progress” (AYP) toward 100% proficiency in the areas of reading and math. FPS failed to meet the AYP target goals for the last three consecutive years as required by the Federal Government. While Friend Public School students have made significant academic gains in the areas of growth and improvement the past year, the United States Department of Education has labeled Friend Public Schools as a Persistently Low-Achieving School (PLAS).
